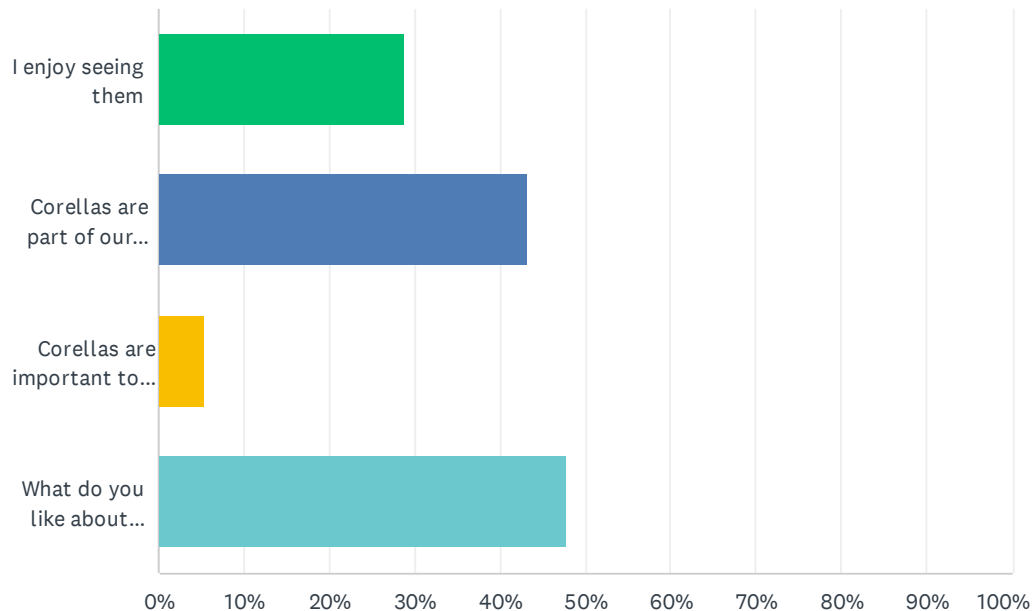

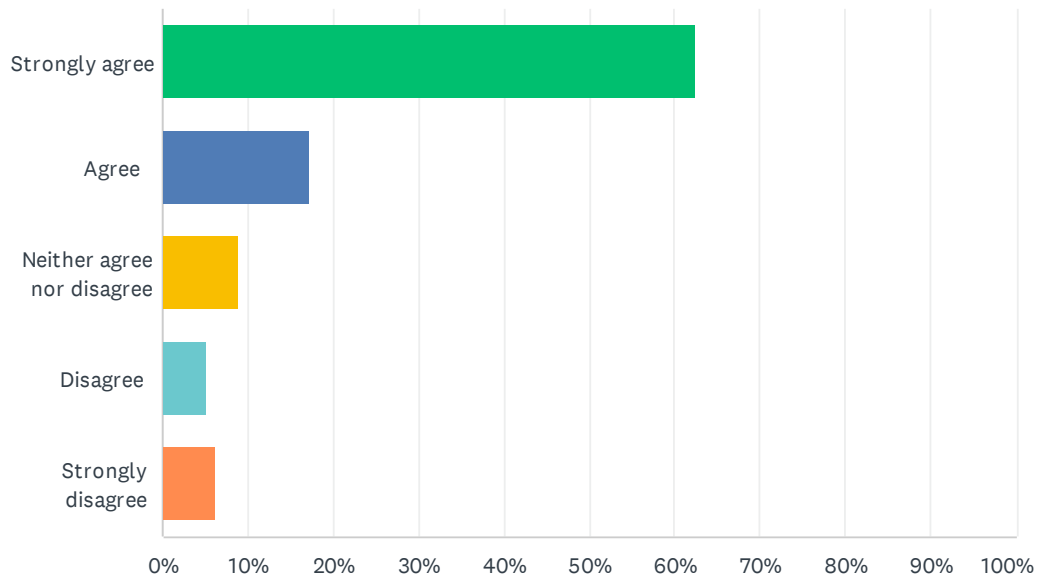

Q5 In your opinion are corellas a problem in our towns

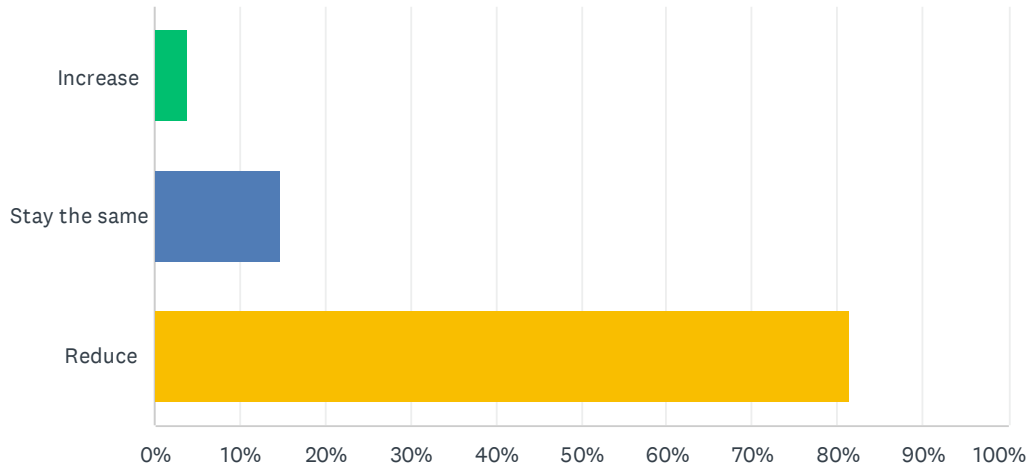

Q6 In the next five years would you like to see the Corella population in our towns

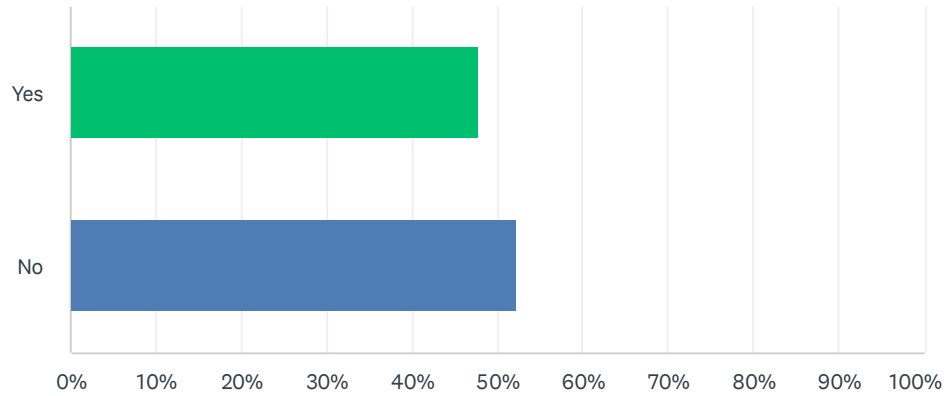

Q7 Have you in the past 5-years had to replace, repair or corella-proof your property?

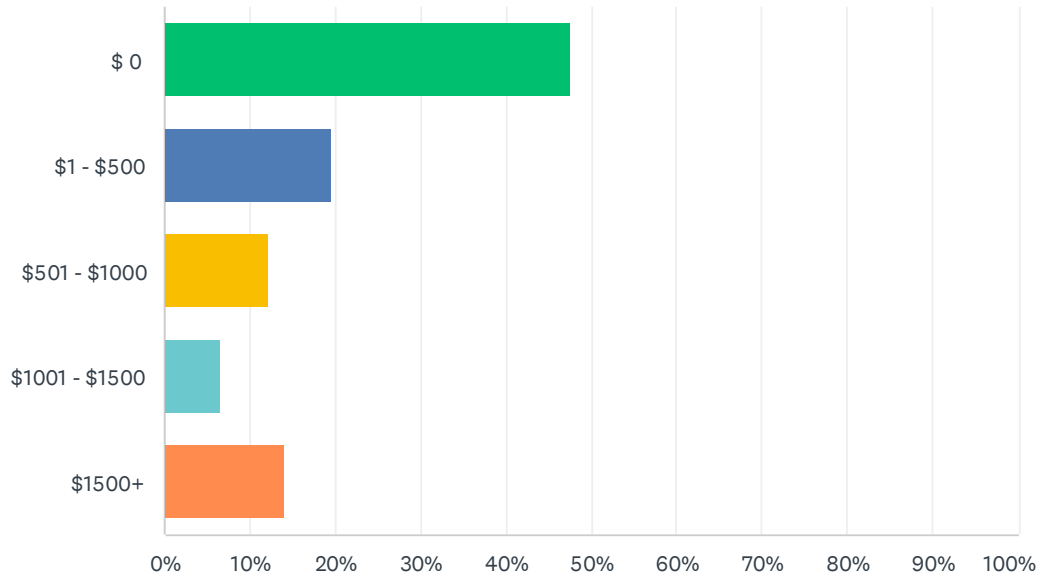

Q8 In the past 5-years the cost to replace, repair and or corella-proof my home has been.

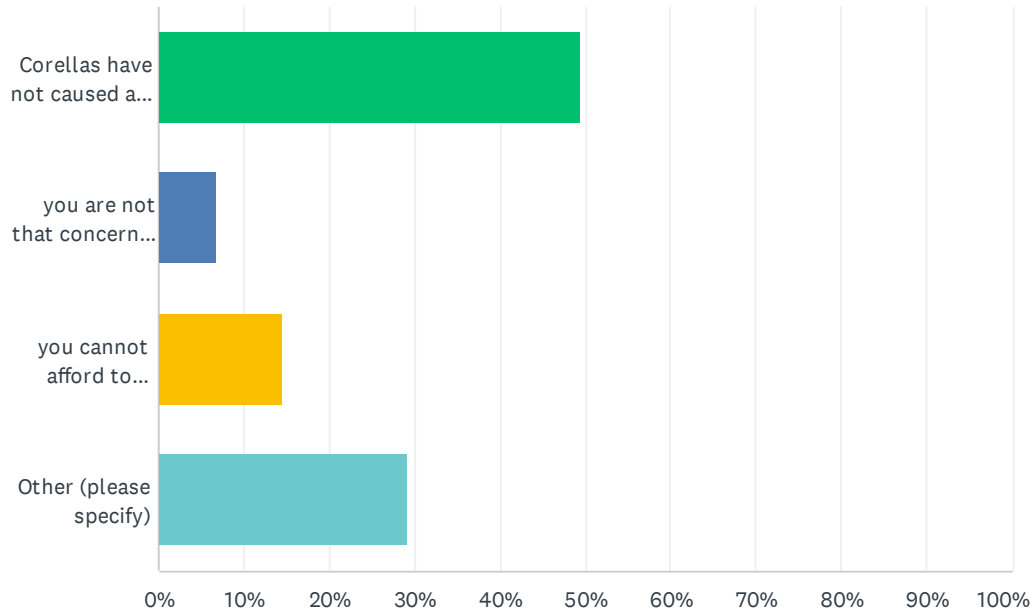

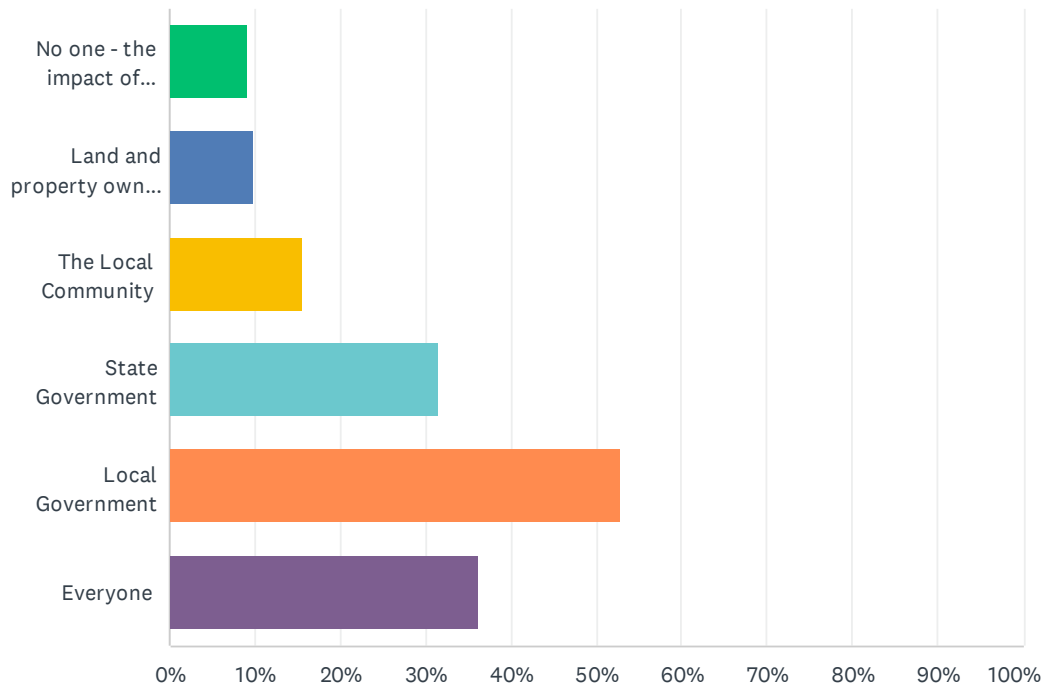
